


# General Park Regulations



Park hours:

8:00 a.m. until 11:00 p.m.

**PARK USE/ RESERVATION.** Whether use of Ecorse park property is by reservation or otherwise, use of public park property is subject to the rules, terms and conditions set forth here.

**LIABILITY FOR GARBAGE AND TRASH.** Any person, group or organization using Ecorse park property specifically agrees that it shall keep the Park grounds free of and shall dispose of all garbage, trash and debris in such a manner as to leave no garbage, trash or debris anywhere on the Park premises. Park users shall bring and use all clean up materials, including, but not limited to garbage bags that will be used to take and remove upon departure from the Park site all garbage, trash and debris.

**NON-EXCLUSIVITY.** Any Park user understands that park property is public and open to the public during the hours of its operation and, therefore, the City cannot guarantee that use of certain park space will be exclusive.

**NO ALCOHOLIC BEVERAGES OR ILLEGAL SUBSTANCES.**

**HOLD HARMLESS, RELEASE AND WAIVER.** To the fullest extent permitted by law, all users of City of Ecorse park property waive, release and forever discharge and hold harmless the City of Ecorse from any and all liability, damages, any and all claims, causes of action, demands of whatsoever kind or nature, or loss, including all costs connected therewith, and for any damages which may be asserted, claimed or recovered against or from the City of Ecorse, its elected and appointed officials, workers, employees, or others working on behalf of the City of Ecorse, by reason of personal injury, including bodily injury or death and/or property damage including loss of use thereof, which may arise as a result of acts, omissions, faults and negligence directly or indirectly from my activities.

It is unlawful to allow:

- Destruction of any plant, animal, or trees on Park property.
- Littering or depositing of trash. Proper receptacles provided must be used.
- Fires. Use of park grills or bar-be-cues are allowed only where designated.
- Structure damage, graffiti, removal of park property, or climbing on any building, shelter or pavilion.
- Conduct which is disorderly or disturbs the peace of others, including music or other noise played at a level that disturbs other.
- Animals that are not leashed and/or under control at all times. No animal may defecate on Park property. Feces must be removed immediately from the area.
- Activities such as flying model planes, golf practice, games, and picnics except in locations designed for those activities.
- Operation of all moving vehicles anywhere except on streets, driveways, or parking lots.
- Signage of any kind to be erected in any manner on Park property or roads adjacent to the Park.
- Firearms, propelling device of any type on Park property.
